# STEP 01

- To have a PhD degree, proficiency in art and specialisation in medicine, dentistry, veterinary medicine or pharmacy.
- A maximum of seven years must have elapsed since the date of obtaining the degree of PhD, proficiency in art and specialisation in medicine, dentistry, veterinary medicine or pharmacy.
- At least two articles published in international indexes (with DOI number).
- To have received an acceptance letter from an advisor who has the qualifications specified in subparagraph (ç) of the first paragraph of Article 4 of the DOSAY Directive.
- To have received a reference letter from two academicians who carry out activities related to the field.
- If the unit where the research will be conducted has special application requirements (foreign language certificate, etc.), to fulfill them.

- The application is submitted online directly to the Dean of Research.
- The documents to be submitted during the application process must comply with the format specified on the website of Ankara University Dean of Research.
- Documents to be submitted by the researcher:

  - -Publication list

  - -PhD/ PhD Equivalent Diploma/
  - Graduation Document -Foreign Language Certificate
  - -Letter of Acceptance from the Counsellor

- The researcher must submit complete documentation.

### **Evaluation**

- The application is evaluated by the Executive Board of the Dean of Research and decided by the University Executive Board.
- Applications based on incomplete or incorrect documents are not evaluated.
- In cases where YÖK approval is required, the application is forwarded to YÖK.

- To have a PhD degree, proficiency in art and specialisation in medicine, dentistry, veterinary medicine or pharmacy.
- A maximum of seven years must have elapsed since the date of obtaining the degree of PhD, proficiency in art, and specialization in medicine, dentistry, veterinary medicine, or pharmacy.
- At least two articles were published in international indexes (with DOI number).
- To have prepared a postdoctoral research project proposal.
- To have an acceptance letter from the supervisor who is a tenured faculty member at the University.\*
- To have received a reference letter from two academicians who carry out activities related to the field,
- If the unit where the research will be conducted has special application requirements (foreign language certificate, etc.), to fulfill them.

#### 3. Submission and evaluation of the application:

- The application is submitted online directly to the Dean of Research.

- 4. The researcher whose application is accepted,
  - Study room and computer are provided.
  - $\bullet\,\,$  ·"Visiting Researcher" identity card is given.
  - Ankara University's corporate e-mail address is provided.
  - The university's social and academic opportunities are provided.
  - The short biography of the researcher and the research project abstract are published on the official website of the Office of the Dean of Research.
  - Turkish language education is provided at TÖMER (upon request and to the extent possible)
  - The opportunity to attend the courses in graduate programs as a guest is provided.
  - Opportunities to participate in organized academic activities are provided.
  - Opportunity to participate in scientific activities such as congresses and seminars outside the city (with the approval of the unit)
  - Upon completion of the research, the researcher will receive a "Postdoctoral Research Participation Certificate" issued in Turkish and English by the Office of the Dean of Research.
- 5. The various obligations of the researcher are as follows:
  - The researcher is responsible for the relevant legislation of YÖK and the University and ethical research principles during the research process.
  - The accepted research topic and supervisor cannot be changed.
  - Research findings are presented during the time at the University.
  - During the research process, "Ankara University" is indicated as the institutional address in the scientific activity and publication related to the subject of the study.
  - The imprint information and a copy of the relevant publication are sent to the University.
  - The Final Report of the conducted study is submitted to the Office of the Dean
    of Research with the approval of the advisor at the end of the research period.

\*The supervisor must have a permanent position at the University and at least one article published in the last five years in journals indexed by Web of Science (not included in the category of predatory journals determined by YÖK) within the scope of Q1, Q2, Q3, and Q4, or at least two articles published in journals within the scope of TR-index.
